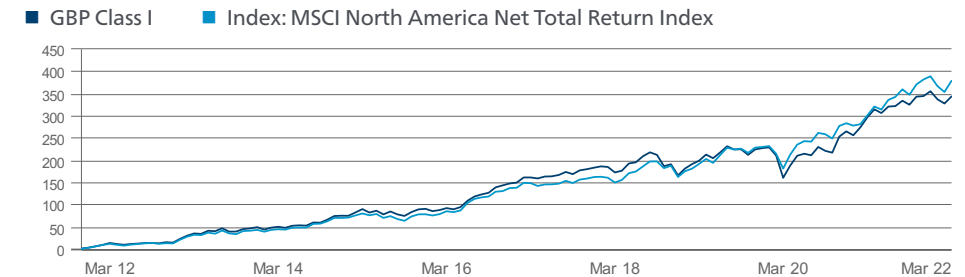

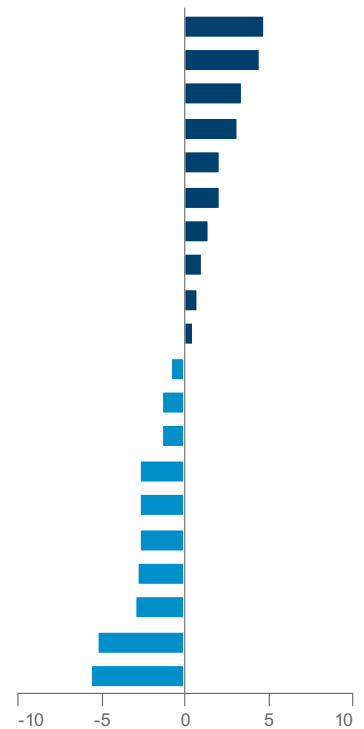

Fund Managers' Comments

North American equity indices recovered ground in March after a difficult start to the year, despite elevated concerns over inflation, interest rates and geopolitical risks, as the first signs of a diplomatic resolution to the Ukraine conflict filtered through. The MSCI North American Net Total Return Index (with net dividends reinvested) gained 3.6% in the month (similar to the S&P 500), while the Fund gained 1.8% (US\$ I Share Class).

There was little corporate news of note during March as we await Q1 2022 earnings announcements. As a result, individual stock moves were dominated by companies' exposures to different macro forces and their defensive qualities. Some companies exposed to discretionary consumer spending and lending activity fared poorly as investors fretted over the pressures from rising living costs and more expensive borrowing costs.

Notable positive stock performances came from: Canadian Natural Resources, an oil producer, United Rentals, an equipment rental company, and Anthem, a health insurer. While Canadian Natural reported strong Q4 2021 results during the month, the primary reason for the move in the stock was likely the global oil price which reached its highest level in a decade. There was little news on either Anthem or United Rentals.

Among the largest detractors from relative performance were Signature Bank, a commercial bank, Qualcomm, a semiconductor company, and IAC/InterActiveCorp, a holding company of internet and media assets. There was little company-specific news or changes in fundamentals, with prices adjusting to reflect prevailing macro concerns.
